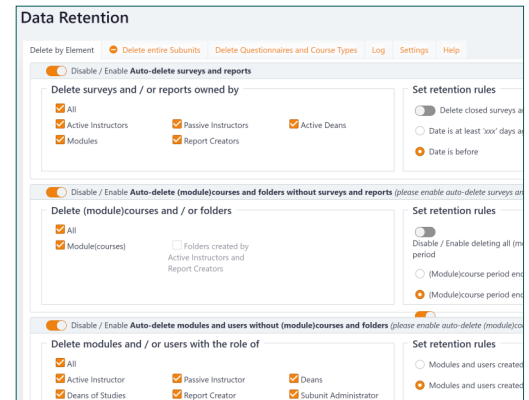

Storing data in a secured environment with ConArch

If you are interested to know more about safely archiving evaluation results and reports outside your evasys system, then please ask about our ConArch solution. Besides data retention functions to automatically delete data from evasys, ConArch offers extensive possibilities to store evasys data (such as PDF reports, CVS or SPSS data, questionnaires) in a secured environment. This facilitates dealing with data privacy regulations while authorized stakeholders maintain quick access to the archived data for reporting and accreditation purposes.

- Configurable retention rules on different levels (e.g. per element type and separate settings for questionnaires and course types), easy to use

The Data Retention plug-in, developed by Consilium, supports evasys version 8.0 or above. It uses the evasys plug-in interfacing, enabling you to work from within the familiar evasys user interface.

The module can either be implemented in your on-premises IT infrastructure or can be offered as part of a hosted evasys environment (evasys Managed Hosting or evasys Cloud Premium).
